1. Review November 27, 2018 Facilities Study Session Outcomes

Bond Funded Projects:

- 1. Approved fire alarm upgrade-Phase 2 projects at Della S. Lindley Elementary, Landau Elementary, Sunny Sands Elementary and Cathedral City High Schools \$1.7 M.
- 2. Approved parking lot renovation at Della S. Lindley Elementary \$1.05 M.
- Approved heating, ventilation, air conditioning in locker rooms at Desert Hot Springs High - \$800,000.










Total Electricity Usage by Fiscal Year


3. Summer Conservation Efforts


- Inventoried summer school programs per site. Grouped summer school classes into classrooms by HVAC zones.
- Energy Management System (EMS)
 - Set classroom air conditioning to unoccupied mode at 4:00pm.
 - Reduce override operation time from 2 hours to 1 hour
 - Lighting Controls
- Developed list of portable classrooms without EMS – M & O staff are manually adjusting thermostats to unoccupied mode.
- Auditing classrooms to ensure shut down procedures are followed







3. Solar Production 2016/17 – District-wide







3. Solar Production 2017/18 – District-wide





3. Solar Production 2018/19 — District-wide






3. Solar Opportunities

1. Mount San Jacinto Continuation High School

2. Rio Vista Elementary School



- On May 30, 2019, the District filed an application through this loan program for \$2,000,000. The balance of the loan must be repaid with energy cost savings within 20 years.
- The District's Prop 39 energy consultant reviewed the 2 school sites and potential size of the solar carports and estimates the District will save at least \$150,000 per year.
- Estimated loan repayments amount of \$100,000 per year.
- District net saving is estimated to be at least \$50,000.
- Notification of award of ECAA loan application will be in October 2019.
