CVC has provided multiple forums for parents, teachers, and school staff to contribute to the development of the plan for our extended learning opportunities, such as the April ELAC meeting and Coffee Chats. We collected data and identified intensive needs through assessments and panorama survey. We also gathered input via the following advisory groups: PTG, ELAC, SST team, and school counselor. Through collaborative discussions, planning, and analysis of feedback, CVC developed the plan for extended learning opportunities with the purpose of promoting plan involvement prior to the plan adoption (in order to meet the June 1 deadline). The district will collaborate with the site in order to gain their insight on the plan, where Principals will further discuss with their staff and other stakeholders.

A description of how students will be identified and the needs of students will be assessed.

CVC will utilize Scholastic NSGRA Running Record data, IAB data, as well as Imagine Math Benchmark Assessments data in order to determine which students have experienced the most learning loss as well as identify the area of need for each student. These assessments and program tools allow for CVC to measure the effectiveness of evidence based services by students in order to identify individualized

learning growth areas and then formulate interventions needed to help close these achievement gaps. CVC will also identify low performing student block and EL students.

The adopted Expanded Learning Grant plan will be posted on the school's website and shared during stakeholder meetings. Personal phone calls will be made by staff to students and families. CVC will use all means of communication such as, Peachjar, Blackboard, and Class Dojo in both English and Spanish to inform our families of the opportunities for supplemental instruction and support.

Cielo Vista Charter commits to providing an intentionally designed program the Summer of 2021, that aligns with the goals set forth: 1. Support Social-Emotional Learning and Well-Being 2. Accelerate progress to close learning gaps 3. Provide positive and engaging learning experiences for all students that include hands-on learning approach. Examples of some supplemental curriculum that will be integrated: ListenWise, Literacy Pro, Imagine Math/Imagine Literacy, Rise Up, Second Step and Inner Explorer.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Cielo Vista Charter is coordinating the use of the Expanded Learning Grant and other federal ESSER funds by budgeting all funding sources across several categories to best meet the needs of the students, staff, and community. In 2021-22, the Expanded Learning Grant funds are primarily budgeted towards closing the achievement gap, diagnostic assessments and progress monitoring; as well as additional paraprofessional staffing. In 2021 - 22, the ESSER funds are primarily budgeted towards school facility improvements to reduce the risk of virus transmission and to support student health needs, implement first best instruction to close an learning gaps that exist. We also will utilize the funds in creating multiple student connectedness activities throughout the year. The funds are also planned to be budgeted towards mental health services and counseling support, personal protective equipment, sanitation supplies, and professional development efforts.

Our first efforts in utilizing these funds will be in the summer of 2021. We will be offering in-person instruction to a wide variety of student groups. These groups include: foster youth, homeless, English Language Learners, SWD, and SED population. These services also include: In person small group or 1 on 1 tutoring. We will also utilize the funds to ensure that our students have access to technology, high-speed internet, and other academic supports. Students at CVC will continue to learn more about restorative circles and trauma informed care. This will allow us to address students' social-emotional health needs and academic needs.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code* (*EC*) Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
