Parent Power Network Meeting Lake Elsinore USD

Parent **P**ower **N**etwork was created by Lake Elsinore Unified School District in September of 2017 to offer support and provide resources to parents of students in special education settings. Although it was initially created specifically for parents of students with Individualized Education Plans, it was expanded to include parents of students in general education settings during the 2018-2019 Academic year.

This has allowed all parents in our district to access resources, receive current information from the district, and to be part of a support network. The initial meeting in September 2018 served as a meet and greet for parents to establish connections, to learn about self-care, and about ways to support their children in school. For the month of October, the district saw greater turnout and provided parents with information about community resources and ways to access them. District staff provided step-by-step navigation through useful websites that would allow parents to access services directly without waiting for referrals.

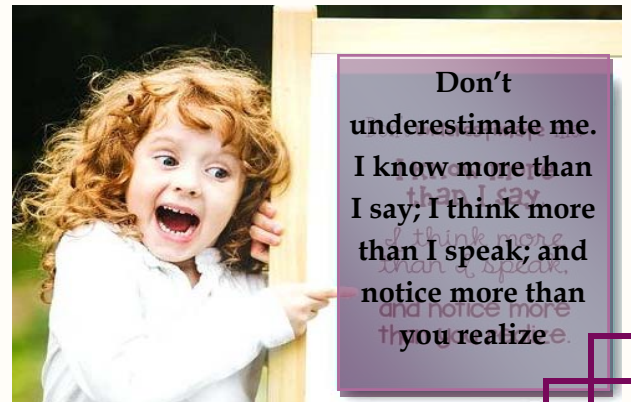
