I. The Title I Program:

Title I is a K-12 program that provides additional academic support and learning opportunities for students at schools with high percentages of socioeconomically disadvantaged children. The program is intended to help ensure that all students meet challenging state academic standards. The goal of Title I is to provide direct instructional support to students and professional development for teachers, in addition to promoting parent education and involvement.

II. Parent Rights Under Title I law, parents have the right to:

- ✓ Review the results of an annual parent involvement effectiveness survey
- Review the school's achievement data to determine if Title I services are effective in meeting the goals for student proficiency in state standards

- ✓ Review and modify the site Title I Parent Engagement Policy with an Integrated Home/School Compact

III. Parent Engagement at Our School:

The School Site Council (SSC) provides parents with the opportunity to be involved in the academic program of the school. The SSC develops, monitors, and evaluates the School Plan for Student Achievement (SPSA); implement programs and services that support students.

IV. School Achievement Data:

Schools analyze and review schoolwide performance data, the Smarter Balanced Assessment Consortium (SBAC) ELA and Math results, the English Language Professional Assessment for California (ELPAC), graduation rates, College and Career Readiness rates, Chronic Absenteeism rates, and Suspension rates. They use the data to align the curriculum to state and district academic standards and adjust their instructional practices based on the findings of the assessment data.

V. School Plan for Student Achievement:

VI. Title I Expenditures:

Schools are allocated Title I funds based upon the percentage of students receiving free or reduced-price lunch. Schools in the Palm Springs Unified School District receive Title I funds if 40 percent (40%) or more of the student population is eligible for the free or reduced-price lunch program. Schools in the Palm Springs Unified School District are ranked according to this percentage and receive a certain amount of Title I money per student.

Title I funds must supplement, not supplant, district funding.

- Title 1 funds: \$78,558 Allocated
 - Teacher on Special Assignment-ELD Support and Small Group Support for Tier 1 and Tier 2 Behavior/SEL Support
 - Parent Engagement Opportunities-Attendance Orientation Event
 - By focusing on providing students social emotional learning support, appropriate behavior management strategies, and small group support, students can more readily focus on their learning.
