Elementary Schools Will Have Slight Schedule Change After Winter Break

Palm Springs Unified School District's elementary schools will have adjusted start and/or dismissal times when students return from winter break on Jan. 9, 2017. The new schedule will allow for increased instructional time for students each day. The adjustments will mean an average of an additional five hours per month at the elementary sites.

"We are pleased that we were able to negotiate the new schedule with our teachers in order to add instructional minutes for our students," said Supt. of Schools Sandra Lyon. "We apologize for any inconvenience the slight change in start and/or end times may create, but we know that more time for learning is of great benefit for our students."

All elementary parents and guardians received a letter from Lyon earlier this month to inform them of the schedule change. Parents or guardians of students who receive bus transportation were provided with a separate letter regarding time changes for pick-up and/or dropoff times at bus stops. Elementary schools have also posted new bell schedules showing recess and lunch times on their websites, which can be accessed through the PSUSD website at psusd.us. PSUSD Dedicates New Richards Center for the Arts

Palm Springs Unified School District and the Foundation for PSUSD held a recent dual celebration to mark the \$17 million renovation to the former Palm Springs High School Auditorium and the dedication of the new Richards Center for the Arts.

October 26 was proclaimed "Richards Center for the Arts Day" in the city of Palm Springs by Mayor Rob Moon at the ceremony attended by nearly 150 people who expressed pride and pleasure in seeing the interior upgrades and renovations combined with the retaining of the exterior building and interior design features of the original historic building.

Following welcoming music by the Palm Springs High Orchestra and performance of the National Anthem, with saxophone solo by PSHS student Maddie Barton, under the direction of Dr. Jason Powell, Supt. of Schools Sandra Lyon welcomed attendees and accepted proclamations and congratulatory certificates from representatives for Congressman Dr. Raul Ruiz, Assemblyman Chad Mayes and Riverside County Fourth District Supervisor John Benoit. Others offering congratulatory remarks and documents included Senator Jeff Stone, Rancho Mirage Mayor Richard Kite and Moon. Other event speakers included Board of Education President Shari Stewart and Palm Springs High Principal Ryan Woll.

Foundation Executive Director Ellen Goodman introduced Rick Moore, representing his mother, Rozene Supple, who has pledged \$2 million to establish an arts endowment and rename the auditorium the Richards Center for the Arts, in honor of her family. Moore then presented a symbolic "big check" for \$2 million to the Board of Education.

The renovations to the auditorium, originally built in the late 1950s, were primarily focused on seismic alterations of the structural foundation. Because the exterior walls are historic, this was accomplished by removing all seating and concrete floor inside, digging down 20 feet and adding additional concrete to the structural footings. The roof was completely removed and replaced with seismically safe attachments, and all new plumbing and electrical systems were installed. Funding included \$4.8 million in state seismic retrofitting funding, and the remainder from the District's Measure E bond funding. An additional \$582,000 came from the city of Palm Springs Measure J funding for new sound and lighting equipment.

Following the cutting of a commemorative ribbon at the conclusion of the ceremony, event attendees were invited to tour the facility and enjoy a catered reception backstage.

My two daughters had an amazing education in PSUSD, and I am so very appreciative for the administrators, counselors, teachers, secretaries, custodians, security staff, mentors and educational leaders that helped to support them in their educational journey. As a lifelong learner, I look forward to growing by learning more about PSUSD and being a change agent for our community."

Gerrell replaced Shari Stewart as the Trustee Area 1 Board of Education representative. Stewart chose not to run for re-election after 17 years of service on the school board. Richard Clapp also begins his third term on the board. He ran unopposed in the November election.



PSUSD Foundation Benefit Concert Set for Jan. 19

The Foundation for the Palm Springs Unified School District will host a benefit concert in the newly opened Richards Center for the Arts on Thursday, Jan. 19, 2017. Featuring the pop music group PostModern Jukebox, the event will also launch the Foundation's "Grab Your Seat" commemorative naming initiative for the Center.

PostModern Jukebox is a rotating music collective known worldwide that creates twists on today's pop music hits, reimagining modern songs into different vintage genres, especially swing and jazz. Tickets range from \$75 for rear orchestra to \$125 for front orchestra and are available at psusd.us/the foundation or by calling (760) 416-8455.

The band covers songs by artists ranging from Lady Gaga and Katy Perry to the White Stripes. Over the years, the group has featured more than 70 different performers and has toured four continents. The January 19 event will be their Coachella Valley debut.

The benefit is co-chaired by Harold Matzner and Helene Galen, and event ambassadors include Michael Childers, Terri Ketover and Ann Sheffer. Debbie Green, of Deb Len Productions, is producing the event.

The "Grab Your Seat" initiative is the cornerstone of an ambitious five-year capital fundraising campaign

for arts education in Palm Springs Unified. The program provides patrons the opportunity to name a theater seat, gallery space or other building amenity in their or a loved one's honor, marked by commemorative plaques, nameplates and custom lettering.

Our 'Grab Your Seat' naming initiative now enables donors to directly enhance the education and the lives of district students and helps make possible arts education of all kinds in our region for decades to come."
